
A Dream Turned Nightmare

On reaching Harish's home, the children took bath and were served with food of their choice. After that, they were given ice cream with small pieces of mango on it. They were enjoying every moment of their stay at uncle's home. In the next couple of days, they were taken by their uncle on a sight-seeing tour of Delhi. Mohan regularly called from Odisha, he talked to all his children. Listening to them, Mohan was happy and quite satisfied.

One morning, after a few days, Harish asked both the girls, to get ready as they would be taken to different homes. They would live there and would be admitted in a school. They were quite happy and accompanied him. When they reached different homes, they were greeted and asked to take rest. The next morning, in their respective houses, both of them were asked to sweep, mop, clean utensils and do the entire household work. When they asked about admission in school, they were beaten blue and black. Whenever they resisted regarding work or asked to go home, they were thrashed badly. This became routine. They were not paid single paise, neither were given sufficient food nor did they get good sleep. Both the girls

Their 'ustad' used to abuse and even beat them when they failed to respond at once to him. In the night, they used to sleep in the garage, without any fan. They used to take bath in the open. From Harish, they got the addresses of the employers of the girls also. The NGO team contacted the girls, and they too were freed from their employers. The whole episode came out in the media. The Social Welfare department gave compensations to these children and arrangements were made for their return to their village. Feeling the pressure of media reports and public, Odisha Government assured all necessary help for the education of Mohan's children. Meanwhile, Harish and his men were arrested and sent to prison for their act.

When the children returned back accompanied by a Government official, Mohan came to know how he had been cheated by his brother-in-law. His son's wisdom and intelligence had helped to make all his children free. If Mohan had been careful enough to enquire about his brother-in-law before sending his children to him, this incident would have never happened.
